2024-2025 Major Accomplishments

National Register

- **Emerson Schoolhouse** – The Emerson Schoolhouse was listed on the National Register in August 2025.
- **Dunham Ranch** – That nomination was approved and forwarded to the keeper in August 2024. Waiting on response from the keeper.
- **SU4100 Medicine Wheel**. Due to unexpected cost, additional grant funding is being requested. Field work will be completed in summer 2026. Nomination to be completed by August 2027.

Projects & Maintenance

- **Kendall Cemetery** – Along with Disney Brunette and Kendall area volunteers, a new buck fence was placed around the cemetery.
- **Bondurant Dipping Vat** – Interpretive sign will be replaced in summer 2026 under a warranty issue. Replacement sign has been received.
- **Deadline Ridge Fire Lookout** - Continued maintenance including opening (remove shutters), general cleaning, and closing (install shutters). Visitation is monitored through a guest book.
- **Monument Ridge Fire Lookout** – Badly in need of stabilization and repair. Forest Service District Ranger Cary Swain is holding up any work on the project. It may be necessary to start some political or public pressure.
- **Cemetery Preservation** – Grave marker plaques were made and installed for Silver Creek cemetery and two isolated Bondurant graves.
- **Opportunities Projects** – Continue to monitor several projects looking for opportunities to help and facilitate preservation. These include the Big Sandy Reservoir Restoration, Holden Hill emigrant inscription site, and the Pinedale Skeletons.

Consultation & Comment

- **Wardell Buffalo Trap** – An effort by Wyoming BLM to repatriate the Wardell Buffalo collection has been stopped/delayed by the State Archeologist and Wyoming archeology community. The board continues to monitor the situation and members have provided comment.



Meeting called to order at 3:00PM by President Clint Gilchrist.

1. **Review minutes from October 22, 2024 regular meeting:** Carmel requested deletion of sentence in #4: "Carmel will ask Shannon at the BLM about Sam Drucker past drone photography info."
MOTION: By Carmel to approve minutes of October 22, 2024 CLG regular board meeting as amended. 2nd by Andrea. Unanimous, motion passes.
2. **Expiring board member terms:** Dave Vlcek and Dawn Ballou terms expire at the end of this year. The County now has a form to fill out to reapply. Must reapply before Sublette Commissioner's meeting in early January.
3. **Monument Ridge Lookout:** Received an email from the Forest Service saying they don't expect to be able to work on Monument Lookout in the near future. Clint suggested we come up with a proposal to do work on a volunteer basis for foundation stabilization, roof repair and windows. Cal said he will come up with a plan for those. Maybe have the Big Piney school shop class work on windows. Cal has dimensions for windows and construction. Can cover windows with plywood. We have plans and proposals, Carmel can give to Cal. Two-year plan. Summer 2025 stabilize, scrub out and clean. Summer 2026, more repairs, windows, shutters. SHPO has to be involved. We can supply labor and materials. Work with Friends of the Bridger-Teton on maintenance plan. We will try to have something to submit by our January 2025 meeting. We haven't seen Ann Oliver's report from the Forest Service tour of the lookout. Big Piney Ranger District Ranger is Cary Swain. The structure is eligible under the National Register.
4. **Dipping Vat – sign damage:** Cal brought the damaged sign down. We will get it replaced. We haven't had that particular problem with any of our other outdoor signs.
5. **Project updates**
 - a) **Emerson School National Register nomination:** Contractors are still working on the report. Should be in by our January meeting. Needs to be in to the State by April 15. We have a picture of the Emerson School on the website that apparently is incorrect-is not Emerson school. We already approved \$1500 to have the contractors create a scrapbook.
 - b) **Dunham Ranch National Register nomination:** Nomination was kicked back by the Registrar. Ann Noble is working on it. Apparently have questions regarding source material and defense of dates. Being worked on by Ann and SHPO. National office seems to be getting more strict on documentation.
 - c) **Deadline Ridge Lookout:** Cal and Bob will go up to Deadline after Thanksgiving and close things up. Need snowmachines to access now.

- d) **Bondurant graves:** Nothing to report. Cal commented he got measurements of the Bondurant school: 41'x31', 1951. Has good foundation under it. Lots of woodpecker holes. The Bondurant Community Club would like to move it down by the Bondurant library. Contacts are Gloria Thomas and Stacy Saunders. Jonita Sommers has said they were using that school until 1973. We aren't looking to do anything with it.
6. **CLG annual report to the State:** Done. Needs to be signed by the County Commissioners. Clint will go in front of them at their next meeting. Clint would like to have our volunteer hours for Forest Service by our January meeting.
 7. **Dormant projects:** Nothing new to report for Courthouse Records, Pinedale Skeletons, Big Sandy Reservoir Enlargement, or Holden Hill project.
 8. **Other business:** none
 9. **Next meeting:** Tuesday, January 28, 2025, Pinedale Library (tentative), 3PM

1. **Review minutes of November 26, 2024 regular board meeting:** (Note: there was no meeting in December 2024)
MOTION: By Bob to approve minutes as presented. 2nd by Carmel. Unanimous, motion passes.
2. **Board members:** Dawn and Dave both reapplied and were approved by the County Commissioners for new terms on this board.
3. **Election of 2025 officers:**
MOTION: By Carmel to keep same slate of officers:
President: Clint Gilchrist
Vice-President: Dave Vlcek
Secretary: Dawn Ballou.
2nd by Andrea. Unanimous, motion passes.
4. **Emerson School – National Register nomination and scrapbook:** We need to do our first review, then send back to the contractors, then to SHPO. We'll have a public meeting in March. The board has some minor edits and comments. Was there a coal shed out back? Clint will talk to SHPO to see if they want to review the draft nomination before the public hearing. Need to advertise the public hearing in the local newspaper.
3:30PM: Don Schooley arrives to meeting
5. **CLG Grants:** The State has more CLG grant money. Deadline is March 14th to apply, short notice, they have around \$60,000. Possible projects: Sommers Medicine Wheel – Clint will talk with land manager Ty Swain. Anything we do would need grant request be signed by Commissioners at their March 4th meeting – short notice. BLM? Clint will talk with Dave Vlcek (not at meeting today) about dating, drone data, footage tied to actual medicine wheel site. Bondurant School? Would school district be interested? Used into the late 70s to 1980s. Not sure if it qualifies for National Register or if there is a site form – Carmel will check. Or we might just document it and give info to school district to have the history. Don mentioned that Katherine Campbell is working on a book about Bondurant history, hopes to publish this year. We don't have a fast ready project for now for this grant money.
6. **Project updates:**
 - a) **Bondurant Dipping Vat sign replacement:** We still need to contact the sign company about getting this sign replaced.
 - b) **Dunham Place National Register nomination:** Contractors are waiting on feedback on what

the Keeper wants. We think/hope the nomination will go through.

c) **Lookouts:** Deadline LO is closed up now, lots of snow. Door is ok, shutters on. No dead bugs inside. Didn't get picture of guest book, but noticed there were some international visitors who signed in. Monument LO: Still looking for source for window repair/rebuild. Cal has talked with a couple people about it (Big Piney High School shop not interested, Grand Teton Park can't do). Maybe Johnny Petersheim (helped us with making windows for Deadline LO, repaired 2 and completely rebuilt 2, very busy). Maybe ask Forest Service if they have someone who makes them. We have a subscription to Lookout Magazine – give back issues to Cal to borrow, might find a source in articles or ads in them.

d) **Graves:** Don is waiting for summer weather to put markers on Bondurant remote graves.

7. **Dormant projects:** Nothing new to report
8. **2025 meeting schedule:** Keep same schedule, every 4th Tuesday of the month, 3:00PM, alternating between Pinedale and Big Piney/Marbleton (usually at the libraries).

MOTION: By Bob to approve 2025 meeting schedule as discussed. 2nd by Andrea. Unanimous, motion passes.

9. **Other Business:**

1) **History Days:** Carmel brought up offering prize for students to do local-focused projects, motivate students. Kids start on projects in September, so have already picked projects for this year. Subjects must meet the national theme. Next year's theme is Rights and Responsibilities in History. Ideas: Finis Mitchell, Pony Express. Their biggest cost is \$ for trip to Washington DC. The Museum Board helps some with that, \$4,000. We don't want to put CLG money towards travel. See if Sublette BOCES will help History Day winners with travel? Clint will talk with the Museum Board. Carmel will talk with Robin Schamber at Sublette BOCES about funding.

2. BLM Archaeologists: Pinedale BLM archaeologists now are Stephen Dadio, Shannon Groves and Alex Dorosin. They sent an email to Clint in January that they want to work with our CLG board. With current federal policies and changes we don't know if any will still be around in future. We will keep lines of communication open.

3. Emerson School – National Register nomination: The nomination went to the State in early February. We will have a public hearing on the proposed nomination at our March meeting. We need to advertise the meeting in the newspaper and will go on Pinedale Online!

MOTION: By Andrea to spend up to \$200 on public notice ad in the Pinedale Roundup for the Emerson Schoolhouse public notice ad prior to our March meeting. 2nd by Bob. Unanimous, motion passes. Dawn will write a short story for the paper and Pinedale Online. We will work on the scrapbook after our March meeting.

4. CLG Grants Round B: Clint talked with Sommers Homestead manager Ty Swain about the medicine wheel. We would need to hurry to get a grant application and get the commissioners to sign the application at their March 15 meeting. Carmel will look into finding the BLM drone footage – she will also check with SHPO and see if they think this is a good project. We would also need to get a letter from Ty in support of the grant.

5. Project updates:

a) **Lookouts:** Calvin brought a draft restoration plan for Monument Lookout. Carmel will type it up and add a bit more. We need to check with Friends of the Bridger-Teton to see if they will do maintenance. Other possible organizations might help.

b) **Bondurant Dipping Vat sign replacement:** We will need to switch the base to a permanent base once we get the sign replaced.

c) **Dunham Place National Register nomination:** Haven't heard anything yet on if approved.

d) **Graves:** Nothing new to report.

6. Dormant projects: Nothing new to report

7. Other Business:

1) **Bondurant school:** Not eligible for National Register. We will do a site form for documentation purposes. Bob will ask some of the Bondurant folks what the status of the

Community Club's old plans to move the building.

2) **Finis Mitchell signs at Pinedale Ball fields:** Peter Paulin with the Sublette Visitor Center has asked the Town of Pinedale about adding Finis Mitchell signs to the ballpark area sign plan around the pond. Town has \$6,000 for signage. Would board be interested in paying for the 3 Finis signs, about \$300 each? Board is ok with it. We'll see what the Town decides to do.

2. Emerson School – National Register nomination: The ad in the Pinedale Roundup cost \$116, was approved at our last meeting. It was also advertised on Pinedale Online (no charge). The State has approved the nomination, with some grammar changes mostly. This meeting includes our public hearing on the proposed nomination. There is no additional public comment on the nomination at this meeting.

OSL rock dating will cost around \$3000, half would be paid by the State, we'd need to come up with \$1500. Might do as a separate project/contract. We will start referring to this site by SU number, SU4100.

4. Monument Ridge Lookout: Cal Thompson put together a proposed rehabilitation project document. Clint will send it to the Forest Service (Bridger-Teton National Forest) and let them look at it. If they approve, we hope to plan a work day up there to work on foundation stabilization, roof, and boarding up the windows.

2. **Emerson School scrapbook:** We have a draft from the contractors. Board members will review it and get back with comments.

3. **SU4100: OSL, RFP, Native Consultation:** Price tag for OSL (Optically Stimulated Luminescence analysis) is around \$19,000, proposal for dating rocks at site. \$15,000 to process 10 samples. 4. **Beaver Ridge Cell Tower:** We have been contacted because of Union proposal to put in a new 80' cell tower next to an existing tower. There are stone circles in the area, bison sheaths also found in area. Dave suggested if they do a cultural survey, we'd like to see the results. Carmel will look to see if there are any other historic/archaeological sites of concern in the area. Clint will respond to this.
5. **2026 SHPO Grant Applications:** November 15 deadline for this round of grant applications. Ones we have considered are Big Piney brick district, Big Piney Town Hall (old bank), BELCO company town buildings, Budd family old house. We will table this for now.
6. **Project Updates**
 - a) **Kendall Cemetery:** Calvin will finish fence/gate tomorrow. Don would like to go back and do more surveying to see if can find any more graves.
(Bob Beiermann left the meeting, 4:15PM)
 - b) **Dipping Vat sign repair:** Cal will go up soon to install sign replacement.
 - c) **Lookouts:** Bob and helpers will go put up the shutters on Deadline lookout in the next couple of weeks to close it up for winter. Forest Service is doing Forest Plan revisions. The Initial Scoping period ended several weeks ago. The County Commissioners are an “interested party.” Clint will look into it. We want to have input on their plans for preserving historic lookouts.
 - d) **Graves:** Baker/Campbell graves in Bondurant have been marked. The Campbell family doesn't

want these graves fenced. Will make them more noticeable, they are on private land.

Can't make info public or do a public presentation because is an archaeological site. Clint will talk with SHPO and ask for recommendations. We will discuss more at our meeting next month.

4. Grant Applications 2026: November 15 deadline. Too short a time frame for this year. Maybe Dan Budd ranch? See if Carmel wants to get background info ahead time.

5. Project Updates:
